Privacy Statement Details

Information We Collect

Information You Provide

Through our websites, products and services, AliCare collects information from you when you choose to share it with us to use our websites, products or services, register with and access certain products or services, sign up for newsletters or our e-mail list, apply for employment, submit inquiries, request quotes, participate in an online survey or promotion, purchase products or services from us, participate in blogs and discussion forums, or otherwise contact us.

The information we collect may include your name, address, telephone number, mobile telephone number, e-mail address, professional industry, job title, personal blog or website addresses, employment history, union affiliation, areas of interest, social security number, member ID, and other information you submit to us. You may also be required to provide certain other information to access and use certain products or services that we offer. We do not require you to register or provide this information to us in order to view our websites or have access to most website content.

Information Collected from Other Sources

AliCare may obtain information about you from other sources, including commercially available sources, such as data aggregators, marketing firms and public databases. This information may include name, demographic information, contact information, professional industry, job title, interests, and publicly-observed data, such as from social media.

Information Collected Automatically

AliCare may use cookies, web beacons, pixel tags, log files, or other technologies to collect certain information about visitors to and users of our websites, products and services to monitor interactions with our websites, products, services and emails, identify you and maintain your user preferences, tailor web content to match your browser capability, analyze usage trends, administer and improve our websites, products, and services, identify irregular website behavior, prevent fraudulent activity and improve security.

For example, we may automatically collect certain non-personal information from you, such as the type of web browser and operating system you use, the name of your Internet Service Provider, Internet Protocol ("IP") address, software version, and coarse geolocation information (for example, based on IP address or location of cellular tower used for the connection). In addition, we may collect information about your browsing behavior, such as the date and time you visit our websites, the amount of time you spend viewing or using our websites, the number of times you return to our websites, and other click-stream or site usage data.

Combining Your Information

AliCare may combine the information we receive from and about you, including personal and non-personal information collected through our websites, products and services for any purpose contained in this privacy statement, including to help us tailor our communications to you and improve our websites, products, and services.

Our Use of Cookies & Similar Technologies

We only use these technologies to monitor your activities on our websites, products and services.

How We Share Your Personal Information

AliCare does not sell or otherwise disclose personally identifiable information about you, **except** as described here.

In the course of doing business, we employ service providers and individuals to perform a variety of functions on our behalf. These service providers may have access to your personally identifiable information if it is needed to perform their functions for us, but **they are not authorized by AliCare to use or disclose the information except as necessary to perform services on our behalf or to comply with legal requirements**. These service providers are also required to maintain the information in confidence.

In addition, we may disclose information where we think it is necessary to investigate or prevent an actual or suspected crime or injury to ourselves or others, if required by law, or in response to a request from law enforcement authorities or other government officials.

During the normal course of our business, AliCare may sell or purchase assets. If another entity acquires, or seeks to acquire, us or any of our assets, information we have collected about you may be transferred to such entity. In addition, if any bankruptcy or reorganization proceeding is brought by or against us,

such information may be considered an asset of ours and may be sold or transferred to third parties. Should a sale or transfer occur, we will use reasonable efforts to try to require that the transferee use personally identifiable information provided through our websites, products and services in a manner that is consistent with this privacy statement.

How We Protect Your Personal Information

Protecting your personal information is important to us. We maintain administrative, technical, and physical safeguards to help protect against unauthorized use, disclosure, alteration, or destruction of the personally identifiable information we collect on or through our websites, products and services.

Choice & Control Over Your Information
